FLORIDA, APPROVING THE USE OF TELECOMMUNICATION SERVICES AND MOBILE COMMUNICATION SERVICES WITH SOFTWARE NAME CONFIDENTIAL AND EXEMPT PER 119.0725 FLORIDA STATUTES, IN ACCORDANCE WITH THE
FOR TELECOMMUNICATION SERVICES, IN THE ESTIMATED ANNUAL AMOUNT OF \$750,000; AUTHORIZING THE CITY MANAGER OR THEIR DESIGNEE TO EXECUTE THE CONTRACT, PURCHASE ORDER(S) AND RENEWAL(S); PROVIDING FOR AN EFFECTIVE DATE.
WHEREAS, the City has utilized [SOFTWARE NAME CONFIDENTIAL AND EXEMPT PER 119.0725 FLORIDA STATUTES,] as its primary cellular telecommunication provider since 2003; and
WHEREAS, the City's Information Technology department has received increasing complaints from users across multiple departments regarding poor cellular coverage and service quality, and despite ongoing engagement with [SOFTWARE NAME CONFIDENTIAL AND EXEMPT PER 119.0725 FLORIDA STATUTES,] to address these issues, proposed improvements are expected to take several years; and
WHEREAS the [SOFTWARE NAME CONFIDENTIAL AND EXEMPT PER 119.0725 FLORIDA STATUTES,] for mobile communication services from August 24, 2021 to August 23, 2026, with the option to renew for a five-year period; and
WHEREAS, pursuant to Section 2-144(f) of the City of Cape Coral, Florida, Code of Ordinances, the City is authorized to purchase goods or services under a contract awarded by another governmental entity by competitive bid
WHEREAS, the City Manager recommends that the Mayor and City Council approve utilizing telecommunication services provided by SOFTWARE NAME CONFIDENTIAL AND EXEMPT PER 119.0725 FLORIDA STATUTES,], in accordance with the in the estimated annual amount of \$750,000.
NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA:
