

RESOLUTION 146 – 25

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, INCREASING THE PURCHASE ORDER TO TETRA TECH, INC. FROM \$200,000 TO \$385,000, FOR DISASTER EMERGENCY DEBRIS REMOVAL MONITORING SERVICES, AS A RESULT OF HURRICANE MILTON; AUTHORIZING THE CITY MANAGER OR THEIR DESIGNEE TO EXECUTE PURCHASE ORDERS, CHANGE ORDERS AND ANY RELATED DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor and City Council adopted Resolution 368-24 on October 30, 2024, which authorized the City Manager to execute all procurement related purchase orders in excess of \$100,000 pertaining to Hurricane Milton; and

WHEREAS, Resolution 368-24 estimated debris removal monitoring services with Tetra Tech, Inc. at \$200,000; and

WHEREAS, after the work was completed, Tetra Tech provided the City with invoices for storm related efforts in the amount of \$377,752.61, plus an estimated \$4,000 for remaining data analyst's work and expenses that have not been billed yet; and

WHEREAS, Tetra Tech's costs for debris removal monitoring services will be submitted to the Federal Emergency Management Agency for reimbursement as part of the Hurricane Milton recovery project; and

WHEREAS, the City Manager recommends that the Mayor and City Council increase the purchase order to Tetra Tech, Inc. from \$200,000 to \$385,000, for disaster emergency debris removal monitoring services as a result of Hurricane Milton.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, AS FOLLOWS:

Section 1. The Mayor and City Council hereby increase the purchase order to Tetra Tech, Inc. from \$200,000 to \$385,000, for disaster emergency debris removal monitoring services as a result of Hurricane Milton.

Section 2. The Mayor and City Council hereby authorize the City Manager or their designee to approve the purchase orders, change orders, and any related documents.

Section 3. This Resolution shall take effect immediately upon its adoption.


