#### CITIZENS INPUT TIME

Lori Haus-Bulcock represented the Board of Directors of Cape Coral Wildlife Trust and voiced support for the Old Golf Course taking into consideration what most of the people want — a passive preserve. She mentioned they were excited to be an environmental group who can work closely with the City on the development of the course.

David Hallsey expressed opposition to the Yacht Club parking garage and other development. He referenced the article in today's newspaper regarding the permits and design phrase.

Councilmember Long left the dais at 5:37 p.m.

Marie Kavanaugh expressed opposition to exceeding the Lake Kennedy budget. She inquired if the seawall has been constructed at Jaycee Park. She asked who initiated the stipend. She asked why the Consent Agenda template has been changed: "A Resolution of the Mayor and City Council of the City of Cape Coral, Florida..." She questioned who initiated the Jaycee Park project.

Jeff Lockhart expressed opposition to the stipend although he was in favor of stipends to teachers and single mothers. He mentioned a conflict of interest on one of the Councilmembers for the Redfish Pointe project.

Councilmember Long returned to the dais at 5:43 p.m.

Karen Niece expressed opposition to spending more money in new park projects until the existing projects are completed.

Chris Doyon, resident of the Celebration Cape neighborhood, voiced his concerns about continuing flooding and drainage problems.

Julia Ettari voiced opposition to changing the zoning for more multi-family development and requested to stop spending, finish projects already in motion. She questioned approving a management company to oversee the department and hiring of another Assistant City Manager. She suggested a forensic audit to address salary concerns.

Kyle L'Hommedieu spoke about F.S. 112.311 where public officers are agents of the people and hold their positions for the benefit of the public. He questioned why taxpayers are not involved in voting on the money being spent.

Councilmember Lastra asked for clarification on the comment of hiring additional staff.

City Manager Ilczyszyn explained:

- When he came into the City Manager's Office, there was a vacant Compliance Manager position in our office.
- He repurposed that position into a second Assistant City Manager in order to help him better run the organization.
- One Assistant City Manager is over the line departments.
- One Assistant City Manager is over the Staff departments.
- His peer research of all of the top ten cities shows that we are still the leanest in executive leadership.

<u>Councilmember Lastra</u> commented on Celebration Cape neighborhood. She sent an email to the speaker from Staff that stated we have some updates to do on that utility easement in his neighborhood and requested clarification.

## City Manager Ilczyszyn explained:

- Speaker was probably referring to the backyard swale which is on the property of Celebration who is responsible
- Meeting SFWMD was there and in compliance with their permit

<u>Councilmember Lastra</u> asked the City Auditor about the speaker's comment on being over budget for Lake Kennedy.

## City Auditor Russell explained:

- Report on Page 5 the budget was changed
- Went from 2016 Parks Master Plan of Lake Kennedy Community Park improvements to Lake Kennedy World Center for Tournaments
- Phase 1 and Phase 2 16 pickleball courts, 6 tennis courts
- Phase 2 an additional 16 pickleball courts and 6 additional tennis courts
- 32 pickleball courts and 12 tennis courts from renovations
- Not currently overbudget Actually underbudget
- Appendix A in the Audit Report we spent \$11.9M of the \$12.3M current budget
- · Started out before amount we quoted in the audit
- Went from \$4.9M to \$12M we did not audit when project was still in the design phase - Budget at the time we did audit in 2019-2020
- · Included findings from that audit in the Appendix in the current audit
- Budget increased 148% because project was no longer just improvements
- It was a whole new design concept completely different from 2016
- We went from fixing around the community park to designing a Racquet Center
- · Change reflected in the title of the audit where it wasn't the Lake Kennedy Project
- No recommendation as far as the financial management
- Looked at all the invoices from start of construction
- Not a financial audit, looked at the planning and the closeout process
- Audit is public record on the City website under Government substantially complete status

#### Councilmember Lastra commented:

- There will be a Yacht Club update forthcoming.
- Old Golf Course opportunities making it a Regional Park, public input, upcoming surveys and Town Halls; wildlife concerns

## Councilmember Donnell commented:

- . Kudos to Staff for work done on the website
- · Interviews with the Youth Council applicants
- · Cape Coral still in its infancy challenges building a City
- Podium -- gateway to our City
- · What are you trying to accomplish in your comments

## Councilmember Steinke commented:

- Lake Kennedy the logic of the numbers
- · Yacht Club budget starts with \$10M

- Lake Kennedy initial budgeted amount changed due to changes made to design

- Report update provided at today's Transportation Advisory Commission multifamily availability compared to single family homes is almost the same percentage as 9 years ago. Still has 80/20 mix, single family/multi-family, lower percentage of multi-family availability based on our City size.

- Guide to public to ask realtor questions about well depth; when the last time pump was changed; have you checked the depth of the well and maintenance
- Ask realtor if there is a permit on file for this home to be off well and on irrigation
- · Getting information and disclosure out to the public
- · Older homes need this type of disclosure
- · Working with industry
- · Focus on direct messaging to help us all with this issue

<u>Mayor Gunter</u> commented on addressing what we are going to do with UEP in that area. He inquired if that would be a discussion at the May 28<sup>th</sup> COW.

City Manager Ilczyszyn responded there would be additional solutions and would bring forward to the last COW before City Council goes on hiatus.

- Completed about half of 120 square miles of the City
- Averaging about one square mile per year
- 120 miles of linear pipe being installed in North 1 West
- Magnitude of the project to dig roads and to get supplies
- Other options that would be presented to Council before hiatus

<u>Councilmember Donnell</u> inquired why are new businesses and homes being built where we are experiencing this crisis.
