

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, APPROVING A CHANGE ORDER TO PURCHASE ORDER NO. 25500732 WITH UNITED SAFETY & ALARMS, INC. FOR ADDITIONAL PERMITTING, INSPECTION AND ADMINISTRATION SERVICES FOR THE PURCHASE OF A FM200 FIRE SUPPRESSION SYSTEM, INCREASING THE PURCHASE ORDER FROM \$129,943.77 TO \$144,943.77; AUTHORIZING THE CITY MANAGER OR THEIR DESIGNEE TO EXECUTE THE CHANGE ORDER TO INCREASE PURCHASE ORDER 25500732; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Mayor and City Council adopted Resolution 331-24 on October 16, 2024, which approved the purchase of a FM200 fire suppression tank to be installed at the North Reverse Osmosis Water Treatment plant, in the amount of \$129,943.77; and

WHEREAS, United Safety & Alarms, Inc. notified the City of additional fees for permitting and inspection services that were not known or captured at the time of the original scope; and

WHEREAS, staff is requesting a change order to increase Purchase Order 25500732, in the amount of \$15,000; and

WHEREAS, the City Manager recommends that the Mayor and City Council approve a Change Order to Purchase Order No. 25500732 to United Safety & Alarms, Inc. from \$129,943.77 to \$144,943.77, for unforeseen permitting and inspection services provided for the installation of the FM200 fire suppression system at the North Reverse Osmosis Water Treatment Plant.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, AS FOLLOWS:

Section 1. The Mayor and City Council hereby approve a Change Order to Purchase Order No. 25500732 to United Safety & Alarms, Inc. from \$129,943.77 to \$144,943.77, for unforeseen permitting and inspection services provided for the installation of the FM200 fire suppression system at the North Reverse Osmosis Water Treatment Plant.

Section 2. The Mayor and City Council hereby authorize the City Manager or their designee to execute the change order.

Section 3. This Resolution shall take effect immediately upon its adoption.


