A Resolution of the Mayor and City Council of the City of Cape Coral, Florida, approving Staffing and Cost Proposal (SCP) ST-05 with Stantec Consulting Services, Inc., to provide professional engineering and design services to design and prepare the Corridor Access Management Plan for the Chiquita Boulevard Corridor, between Veterans Memorial Parkway to Cape Coral Parkway, for a not to exceed amount of \$494,451; authorizing the City Manager or their designee to execute the Staffing and Cost Proposal and purchase order(s).

#### **Summary Explanation and Background**

To enhance roadway safety and alleviate congestion caused by traffic backups in the travel lanes along Chiquita Boulevard South, the City is proposing improvements to the medians between Veterans Memorial Parkway and Cape Coral Parkway. These enhancements will include intersection modifications and the addition of left-turn lanes to improve traffic flow.

Throughout this three-mile corridor, all medians and median openings will be evaluated for potential access modifications. The project will include an access management study, sight distance analysis, curbing design, and landscape planning. Additional design components may involve curb and gutter, resurfacing, pavement reconstruction, updated signage, and drainage enhancements as needed.

On March 20, 2024, Resolution 71-24 authorized the use of the Professional Consultant Continuing Services (CCNA) - Master Agreement Library with 36 Professional Engineering Firms. The firms were pre-qualified for specific engineering categories based on their specific expertise to provide support for continuing services projects on an as needed basis.

A master agreement for Stantec Consulting Services, Inc., Contract # CON-RFQ2323KR-HH for professional services was executed on March 21, 2024 to allow for future work assignments. The individual work assignment authorizes the firm to complete professional services using Staffing Cost Proposals (SCP). The SCP follows the terms and conditions of the Master Agreement and incorporates the detailed work assignment for a specific task that needs to be completed.

Based on the continuing Professional Consultant Services Contract No. CON-RFQ2323KR-HH, Stantec Consulting Services, Inc. was chosen from the Professional Services Library to provide the professional services for this project.

Stantec Consulting Services, Inc. has submitted a Staffing and Cost Proposal (SCP) ST-05 based on the required scope of work for the Not-to-Exceed amount of \$494,451.

If approved, the Staffing Cost Proposal #ST-05 with Stantec Consulting Services, Inc. for the professional engineering services in connection with the Chiquita Corridor Roadway Improvements between Veterans Memorial Parkway and Cape Coral Parkway is for a not to exceed amount of \$494,451. The duration for design is 300 calendar days after the Notice to Proceed is issued and 365 calendar days for construction assistance once construction starts.
