ORDINANCE 19 - 25

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF CAPE CORAL, FLORIDA, THAT AMENDS THE CITY OF CAPE CORAL, FLORIDA OFFICIAL ZONING DISTRICT MAP OF ALL PROPERTY WITHIN THE LIMITS OF THE CITY OF CAPE CORAL, BY REZONING PROPERTY DESCRIBED AS LOTS 60 THROUGH 67, BLOCK 809, UNIT 22, CAPE CORAL SUBDIVISION, FROM PROFESSIONAL (P) TO RESIDENTIAL MULTI-FAMILY LOW (RML) ZONE; PROPERTIES ARE LOCATED AT 1224 COUNTRY CLUB BOULEVARD AND 1306 COUNTRY CLUB BOULEVARD; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Mayor and City Council have considered testimony, evidence, documentation and the application submitted by BLUE WATER TRUST LLC, a Florida Limited Liability Company, to rezone the below-described property from PROFESSIONAL (P) to RESIDENTIAL MULTI-FAMILY LOW (RML) zone, and considered the recommendations of the Hearing Examiner and City Staff, and have considered the City of Cape Coral Comprehensive Plan with this zoning request.

NOW, THEREFORE, THE CITY OF CAPE CORAL, FLORIDA, HEREBY ORDAINS PURSUANT TO THE LAWS OF FLORIDA, AND OTHER APPLICABLE LAWS, THIS ORDINANCE:

Section 1. That the City of Cape Coral, Florida Official Zoning District Map of all of the property within the limits of the City of Cape Coral is hereby amended with respect to real property described as follows:

PROFESSIONAL (P) TO RESIDENTIAL MULTI-FAMILY LOW (RML) ZONE

Lots 60-67, Block 809, Unit 22, Cape Coral Subdivision, according to the Plat thereof as recorded in Plat Book 14, Page 5, Inclusive, in the Public Records of Lee County, Florida.

PROPERTIES LOCATED AT: 1224 COUNTRY CLUB BOULEVARD & 1306 COUNTRY CLUB BOULEVARD

and the City shall amend the City of Cape Coral Official Zoning District Map to reflect this zoning change.

That the amendments to the City of Cape Coral Official Zoning District Map as prescribed herein are consistent with the City of Cape Coral Comprehensive Plan.

Section 2. Severability. In the event that any portion or section of this ordinance is determined to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining portions or sections of this ordinance which shall remain in full force and effect.

Section 3. Effective Date. This ordinance shall become effective immediately after its adoption by the City Council.
