A Resolution of the Mayor and City Council of the City of Cape Coral, Florida, awarding Bid No. BUT2569LC to Odyssey Manufacturing, Co. for the supply and delivery of sodium hypochlorite; approving Contract No. BUT2569LC to Odyssey Manufacturing for the supply and delivery of sodium hypochlorite for the City's Utilities Water Production and Reclamation Facilities, in the estimated annual amount of \$2,193,040, not to exceed budgetary limits; authorizing the City Manager or their designee to execute the contract, purchase order(s) and renewal(s).

Duration: One year with three optional one-year renewals

Summary Explanation and Background

The Utilities Water Production Division and Water Reclamation Division utilize sodium hypochlorite (high strength liquid bleach) for disinfection of our drinking water, wastewater, and irrigation/reuse water systems

On March 19, 2025, Invitation to Bid #BUT2569LC was issued to secure a contract for the supply and delivery of sodium hypochlorite and 12 plan holders downloaded the documents.

On April 22, 2025, two responses were received, Allied Universal Corporation and Odyssey Manufacturing Co.

After staff evaluation of the bid responses, Odyssey Manufacturing Co. was deemed the lowest responsive, responsible bidder meeting the specifications and requirements of the invitation to bid. Odyssey Manufacturing Co. consistently delivers a high-quality product with outstanding customer service. Odyssey Manufacturing Co.'s bleach product is filtered and their manufacturing process uses an ultra-pure salt which reduces impurities in the final product.

If approved, the contract provides a product delivered price of \$1.58 per gallon, with an estimated annual cost of \$2,193,040, not to exceed budgetary limits. The contract term is for one year with three optional one-year renewals.

The procurement is in accordance with City of Cape Coral Code of Ordinances Chapter 2, Article VII, Division 1, Section 2-144(a) of the Procurement Ordinance "Competitive sealed bidding".
