Summary Explanation and Background

The Resolution before you establishes the Fiscal Year 2025-2026 Solid Waste Collection rates for commercial establishments and large scale multi-family dwellings for the City's mandatory refuse collection program.

Section 9-72 of the City Ordinances requires the City to establish rates prior to October 1 each year. The rates are comprised of two components - collection and disposal. The rate proposed incorporates an increase of 1.66%, which represents an adjustment for Consumer Price Index (CPI). This adjustment was also represented in the residential rate.
